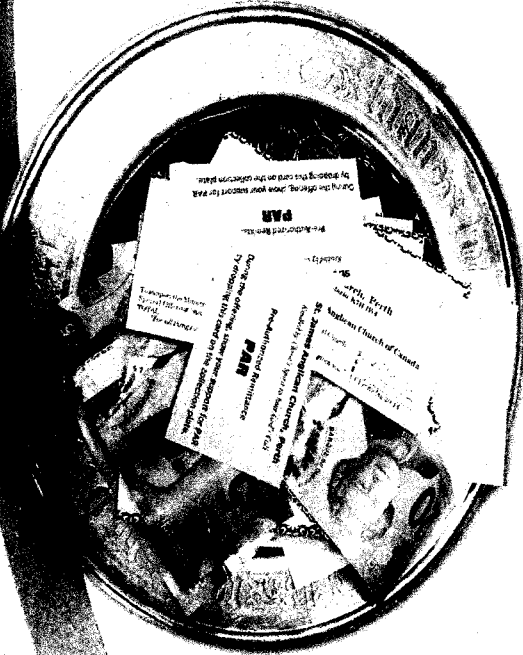


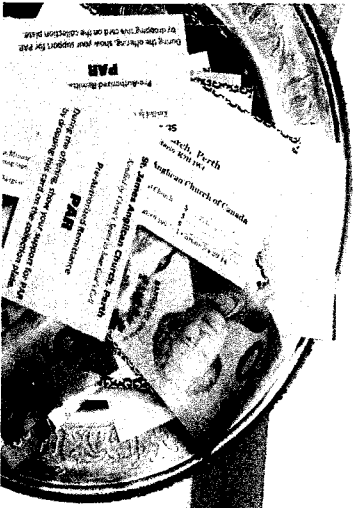

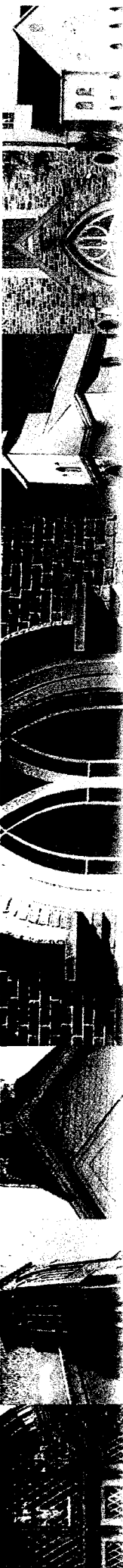
**Pre-authorized Remittance**

## How to get involved:

**When your congregation has decided to participate in PAR, and if you are going to participate, then you:**

- 1 Decide the amount of your monthly offering (St. James, PWRDF).
- 2 Fill in the Authorization Card and attach a sample cheque from your account marked "Sample" or "Void."
- 3 Give both to your church treasurer or designated officer, or place both on the offering plate.

## Advantages to the contributor:

- 1 Regular support of your church
- 2 Continual support of your home church and the PWRDF even when you are away
- 3 Avoidance of "catch-up" periods

## Advantages to the congregation:

- 1 Regular flow of contributions
- 2 Reduction of paper work and bookkeeping
- 3 Increase in givings during the summer months

**"Whether or not I am there...**

**... my church has ongoing commitments every week that need my offering. My church is important to me, and so is my financial commitment to its work. That is why I use the PAR (Pre-Authorized Remittance) system to fulfill my commitment."**

If you have automatic debits from your bank account to pay for insurance, cable TV, taxes, fuel, or mortgage, then you understand the PAR principle. It means regular contributions throughout the year.

For many, PAR is a convenient way to make their church offerings a priority, and to honour their church commitment. When you sign up for PAR, you guarantee your offering every month to your church.

Your account will be debited on or about the 20th of the month and your congregation's account credited with the amount payable from all members who participate.
